## INCIDENT:

On December 16, 2009, I was paged to respond to Kalomara Hospital to investigate report of a past sexual assault. The alleged perpetrator, Mark Kocaj was recently arrested on December 12, 2009 for Simple Assault and Disorderly Conduct stemming from a domestic incident also involving Kara Kocaj (Case Number 09-3710). When I arrived at the hospital, I spoke with Jenifer Markowitz, RN, a Sexual Assault Nurse Examiner. Ms. Markowitz informed me that she treated Ms. Kocaj and performed a sexual assault examination. I was taken to the SANE room at the hospital, where Ms. Kocaj was talking with an advocate from the local domestic violence shelter.

I introduced myself and proceeded to interview Ms. Kocaj. Both Ms. Markowitz and the advocate were present for the interview. Kara appeared distraught. Her eyes were red and swollen, as though she had been crying. Her nose was running and she continuously reached for additional tissues during the interview.

Ms. Kocaj relayed the following information. On Thursday, December 3, 2009, her husband, Mark Kocaj, came home drunk again and he would not let her sleep. She pretended to be asleep but he rolled her over on her back and told her that he wanted to have sex. Kara stated that she told him "no" and that she was tired and had to get up in a few hours. Mark became angry and tried to put his hands around her throat. Kara explained that when she tried to stop him and grab his hands, he hit her in the head several times. Kara stated that she was so scared that she just froze. Kara then stated that her husband then crawled on top of her, pinned her arms over her head with one hand and pulled off her underwear and pried her legs apart with the other and had intercourse with her.

I asked why Kara did not report the incident immediately. She explained that she did not tell anyone until now because she was afraid and did not know what to do.
