- 3. How do we improve sex offender management?




Core Components Of Allegheny County Sex Offender Court

- Keeping Victims Informed
- Charge specific, case identification
- Scheduling Cases Promptly
- Dedicated and trained Judges

- Continuous judicial monitoring – review hearings
- Convene regular meetings with criminal justice agencies and service providers
- Providing court personnel and partners with education & training

Benefits From Collaboration

- Improved systems' response for victims
- Funded pop-up polygraphs
- Specialized Training for multidisciplinary team
- Special Conditions form
- Informed Decision Making
- Strong Relationships between MDT members



Examples Of Special Conditions

- SEX OFFENDER TREATMENT
- No contact with minors
- No alcohol
- No internet access devices
- No Sexually stimulating material
- No unsupervised contact with minors if Offender has own children

Case Identification

- All original offenses by an offender that requires to register for Megan's Law
- Charges added under Adam Walsh Act are left to the discretion of the SOC judges





Benefits Of Specialized Court

- Imposing special conditions on offenders
- Monitoring of mandated sex offender treatment
- Accepted use of polygraph as a treatment/maintenance tool
- Improved and direct relationship between specialized probation/parole officers and court
- Quick judicial response to violations and high risk behaviors
- Court mandates treatment only to providers approved by the PA Sex Offender Assessment Board (SOAB).

Benefit Of Sex Offender Court Docket

- Charge specific not optional
- Two Specialized Judges
- Swift court process/calendar
- Continual judicial monitoring



^{*}Judicial Monitoring - most powerful tool in the sex offender court model

Allegheny County Probation Department

- Cases Supervised: 25,697
- Probation Officers: 130
- Sex Offender Probation Officers: 4 Officers/317 supervised/ only 177 are SOC
- Sex Offenders Supervised: Under 2%

- Understanding of sex offender behavior
- Consistency in sentencing
- Specified Docket
- Designated Judges
- Specialized Supervision
- Clarity of goals

- Specialized Unit
- Special conditions
- Informed decision making
- Interventions/Sanctions




Sharing Information

- Polygraph Exam admissions
- Monthly Meetings
- Treatment Goals
- Probation Goals
- Boundaries need to be understood and respected



Court and Violations statistics



24 of 191 NOT Megan's Law but under judge's request were kept for sex offender supervision

Challenges vs. Goals of treatment

- Denial
- Deception
- Deviant sexual interest
- Distorted cognitive beliefs
